Welcome to Fort Lauderdale! On behalf of the Officers and Executive Committee, I welcome you to the APEE 45th Meeting. This year's theme is: **The Threat of the 21st Century Populism**. Countries in Latin America and Europe have seen a rise of populist governments. Populist rhetoric has been increasing in the

United States as well. This meeting seeks to understand the phenomena of the 21st century populism. What are the main similarities and differences between the old populism and the 21st century version? What are the main threats to economic and civil liberties that arise from populism? How do institutions impact the emergence and advancement of populist governments? What lessons can be learned from the return of populism? Can a democracy be shielded against populism or is this a latent threat inherent to a democratic government?

This year's theme could not be more important or timely. The real welfare of people depends on the institutions their countries adopt. The topics of socialism and capitalism, along with their benefits and liabilities, are of intense discussion and debate in contemporary politics worldwide. Perhaps it is time, then, to pay closer attention to the resurgence of populism, to examine both its history and its contemporary manifestations, to see what conclusions we can draw about the institutions and policies we should recommend to protect civic liberties.

Sessions over these next two days will include papers that present empirical data and moral arguments regarding a wide range of topics on the proper scope, activity, and authority of the state in promoting freedom, virtue, and prosperity.

Álvaro Vargas Llosa, the 2021 Thomas Jefferson Award Recipient, will give remarks titled "Populism – Democracy's Disease." In the R. Bruce Den Uyl Memorial Plenary Lecture, Kevin Grier will present recent findings regarding the consequences of Latin American left populism and a prescription for getting back on track.

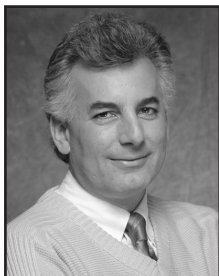

2021 Distinguished Fellow Award Gerald Gunderson



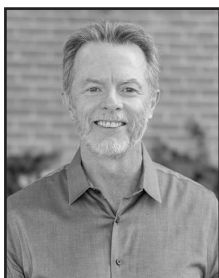

In Memory of Robert Bruce Den Uyl



Robert Bruce Den Uyl was a pioneer in the application of economic reasoning to new areas. He received his Bachelor of Arts degree in Economics from Lawrence University of Wisconsin and his Master of Science degree in Resource Economics from the University of Michigan where he was ABD before moving to the private sector. He was a Managing Director at AlixPartners, an international consulting firm known for solving complex and critical business challenges. Among other things, he applied economic reasoning to business valuations usually handled through financial analysis. He had over 30 years of experience providing valuation analysis, expert testimony and financial consulting for a diverse range of industries internationally. He was highly regarded by his clients and peers for his expertise, leadership and commitment to his practice. Since high school, when he discovered the works of Ayn Rand, Bruce had been intrigued with the concept of individual freedom. Studying economics in college he focused on free market ideals and supported free market causes. Bruce lost a valiant battle with cancer in September 2018. He is remembered for his intellectual curiosity and integrity, his dedication to his work and most of all, his love for his family and friends.

His family is pleased to honor his memory with support for a plenary session on Monday April 12, 2021 featuring remarks from Kevin Grier of Texas Tech University on the topic, 'The Consequences of Latin American Left Populism and a Prescription for Getting Back on Track.'

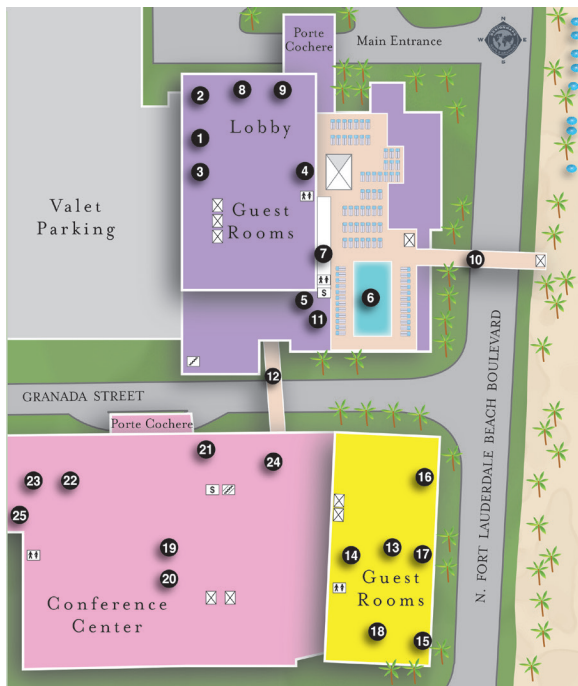

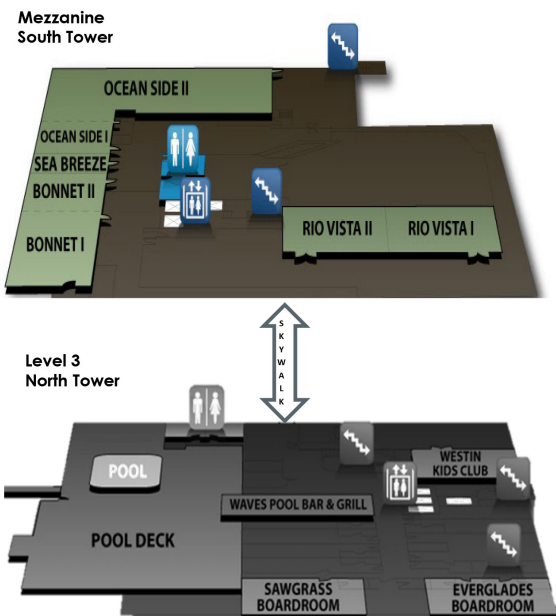

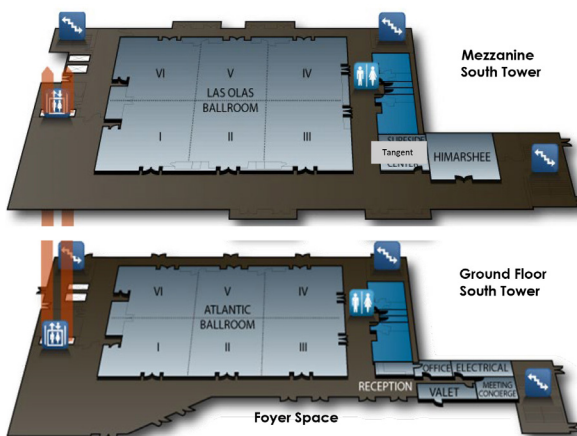

Instructions to Authors Submitting Manuscripts for *The Journal of Private Enterprise*

All papers presented at the annual conference of The Association of Private Enterprise Education may be submitted for publication in *The Journal of Private Enterprise*. Other submissions must come either by nomination by a member of the editorial board or by paying a submission fee of \$45 for members, \$126 for non-members, (\$45 submission fee plus \$81 membership fee). Submissions should be uploaded to www.editorialmanager.com/jpenterprise. Articles of 12 to 15 pages of double-spaced text are preferred, but longer manuscripts will be considered if the content appears worthwhile. Papers reviewed and accepted by the members of the Editorial Board will be published as full-length refereed articles. *The Journal* no longer publishes abstracts or book reviews. In addition, a regular section of *The Journal* is devoted to educational notes that average 5 pages; these short accounts describe innovations in teaching topics in private enterprise of interest to *Journal* readers. Those interested in particular educational notes should contact the author directly.

Before publication, articles and notes in *The Journal* must conform to the current stylistic guidelines based on the *Chicago Manual of Style* and *Merriam Webster's Collegiate Dictionary*. Please cite sources in the text by the author's name and year of publication, for example (Smith, 1996, p.3). A full reference list should appear at the end of the article. References must be formatted exactly according to the guidelines of the American Economic Association. Only notes that add comments beyond the citation require a separate footnote.

For all submissions, please remove author information from the Word document, including the file properties document author information. Please include author contact information in the body of the email.
